Sep. 8-25	Notification period, candidate information sessions held
Oct. 5-9	Candidacy Week (filing period for Candidate Declarations)
Oct. 9, 5 p.m.	Deadline to submit Candidate Declaration forms, voter pamphlet statement, and photo to Office of the City Clerk
Oct. 26	Ballots, instructions, and voter pamphlets mailed to eligible voters' home addresses
Nov. 2-6	Election Week – ballots returned by mail or completed online
Nov. 16 or earlier	Election results certified by the City Clerk
Nov. 16 or earlier	Candidates notified of election results by City Clerk

You will have the choice to vote electronically or with a paper ballot.

Please check Workday to ensure that your correct address is on file.
