 - i. If you remove the bus eligible – how many of the non-bus eligible are using active transpo vs driving? Of the people who can walk/bike/bus/scoot, how many are? We assume they're probably mostly in a private car, but what's the data?
 1. Beth starting to use GIS to calculate what percentage of each attendance area is in the walk zone. Can we compare things more equitably (kids in walk zones vs kids outside of walk zones, some areas naturally won't have as high of active transpo as others will

due to their geography/their walk zones/etc.) – **will share findings at some point in the future**

- ii. Could we have percentage of schools participating in Travel Tally each year rather than just number of schools?
- iii. Trends across equity-priority tiers
 - 1. Correlation between equity tier and the percent of attendance area that is within the walk zone – **could we find data on this? Perhaps something to look into.** Kind of like the data Beth is looking into, but broken into the equity tiers
 - 2. Who really has access to walking? Brings up questions around land use
 - 3. The data shown here is not linear (no clear directional trend)
 - 4. Note – most schools are Tier 4, so the sample sizes of Tier 1-3 are really small. **Maybe see how the data looks if Tiers 1-3 are combined and compared against Tier 4?**
